# **About the West Coast Fever**

West Coast Fever is Western Australia's representative in the world's best netball competition, Suncorp Super Netball.

**West Coast Fever Reserves**, formally known as Western Sting, competes in the new formed Super Netball Reserves competition, and plays an integral part in the Netball WA talent pathway.

The **West Coast Fever Futures** program integrates more than 60 athletes from across WA into a new talent pathway. The 17/U and 19/U West Coast Fever Futures Squads receive education, training and development opportunities as the next generation of emerging talent. Players are selected from the West Coast Fever Futures Squads to represent WA in their respective age groups at the National Championships each year.

In addition, regional and metropolitan academies feed into the talent pathway, engaging netballers throughout WA in the **Fever In Time** program.



# **General Manager Performance & Pathways**

The General Manager of Performance and Pathways is responsible for the strategic direction, leadership and management of Netball WA's key Elite programs including West Coast Fever, West Coast Fever Reserves, West Coast Fever Futures including Western Australia State Representative Teams, Talent Pathway Programs including Fever In Time and Performance & Pathway competitions including the West Australian Netball League (WANL).

Reporting to the Group CEO as part of the senior executive team, this role manages a key department within the Netball WA operations, providing strategic and operational management and leadership to ensure the delivery of the department's core business activities and strategic objectives.

The role is responsible for:

- Developing and delivering a comprehensive High Performance Plan ensuring a world leading system giving West Coast Fever a sustainable competitive advantage
- Ensuring Pathways and Competitions are connected in order to identify, support and celebrate talented players, coaches and officials and ensure a thriving pipeline of Western Australian Talent
- Evolve the Western Australian Netball League to be the preeminent state based competition

To be considered for this role you will need to be a driven and dynamic leader who is able to swiftly build collaborative relationships, credibility and strategic partnerships with a wide range of internal and external stakeholders, including volunteers. This role will require tough decisions to be made at times and the ability to clearly communicate with compassion is essential.

Strategic in thinking and practice, you must demonstrate the ability to deliver multiple projects and plans concurrently, solving problems on the run whilst maintaining a big picture viewpoint, and remaining calm and measured in high pressure and crisis situations.

You must have extensive experience, understanding of, and expertise in, high performance sport, with the capacity to deliver a high performance culture and embed values in an elite sporting context. A netball background is highly desirable but not essential; however you must have a strong ambition for the sport's success.

This is a unique opportunity to make a positive impact on the sustained success of the West Coast Fever and elite pathways both strategically and operationally throughout netball not only in Western Australia, but also flowing into the national and international levels of the sport.



# **Responsibilities and Duties**

#### **Netball Strategy**

- Develop, implement and drive outcomes of a comprehensive Netball High Performance Plan aligned to Netball WA's Strategic Plan that supports the delivery of the departments Game Plan and Match Winners and presented for Group CEO and Board approval
- Explore new strategic priorities to ensure the ongoing sustainability of the West Coast Fever Netball Club, working towards our vision to be the best on and off the court and to continue as a Club of Choice for the world's best
- Drive the review and planning meetings calendar for the Performance and Pathway unit and lead the integration with other key departments to ensure strategic alignment
- Oversee the delivery, structure and competitiveness of the Western Australia Netball League

#### **High Performance Culture**

- Collaborate with the Head Coach, High Performance Staff and contractors, and Netball leaders to drive a High Performance Culture
- Develop and implement staff engagement initiatives including a culture of continuous learning and learning orientation, maximising the engagement and career development of staff
- Ensure the club delivers a wellbeing program that supports player retention, mental and physical health and life skills for the playing group and associated staff
- Establish and manage clear cultural guidelines and programs for players and staff consistent with the teams' values

#### Administration

- Member of the Netball WA Executive team and present to Netball WA Board as required
- Attract, employ and manage key appointments responsible for the delivery of Coaching, Physical Performance, Administration, Welfare, Medical and List Management functions within the High Performance Unit.
- Oversee and manage key appointments of Pathway and Competition Staff
- Manage and mentor the Head Coach and meet regularly to monitor the netball program and develop strategies for its continued success
- Work closely with the Head of Performance and medical staff, to ensure the playing group are provided with the most contemporary approved medical, strength & conditioning and psychology advice, guidance and care
- Ensure the delivery of community and fan engagement strategies including the delivery of WCF Clinics, preseason activities, appearances, integration of team with broadcasters and other requirements, designed to meet the engagement of members, fans, corporate and government partners and the broader netball community
- Provide leadership and executive management across the Performance and Pathway department

#### **Finance**

- Oversee and prepare the Performance and Pathway budget for approval
- Manage the Performance and Pathway department expenses within the approved annual budget
- Provide accurate quarterly forecasts

#### Compliance

- Through values driven leadership, role model the highest levels of personal integrity in all activities, internal and external to the organisation
- Responsible for all Netball reporting to the Group CEO and maintaining a club culture of the highest standards of reporting and compliance around all Netball/SNL guidelines
- Working closely with the List Management
   Committee and Chief Operating Officer to develop,
   implement and manage the Total Player Payments
   (TPP) salary cap structure ensuring all player
   negotiations comply with the SSN TPP
   requirements and additional services regulations
- Ensure all Integrity framework is implemented throughout the Performance and Pathway Department
- Lead a culture of continuous improvement ensuring regular reviews of practices and processes and making recommendations for improvements
- Know, direct and implement all matters relating to Netball WA's Selection Policy and ensure compliance to Netball Australia guidelines/policies for all Elite and Pathway teams
- Present pre, mid and post Season to the Board providing updates for progress, risk concerns and recommendations for improvements and changes relative to West Coast Fever
- Provide Pathway and Competition updates for inclusion with the board pack as requested
- Adhere to and comply with all NWA policies and procedures

# Responsibilities (continued)

#### **List Management**

- Provision of a 3 year and annual contracting model signed off by the Group CEO prior to the commencement of the contract period
- Maintain a comprehensive knowledge of the SNL rules and regulations including the requirements of the Collective Player Agreement (CPA) and the impact of the management of the High Performance Department
- Oversee the Club's talent identification and recruitment procedures in conjunction with the List Management Committee, ensuring adherences to policies and procedures
- Oversee the Clubs list management and recruitment processes in conjunction with the relevant stakeholders to ensure alignment with list management strategic objectives and adherence to policies and procedures

#### **Promotion and Development**

- Support Netball WA and West Coast Fever partners including government, corporate and community
- Attend games and supporting club functions whilst actively engaging in networking opportunities to build the club profile in the corporate sphere
- In consultation with executive and other key staff, develop appropriate strategies for managing media interest and respond as required
- Represent the Club as appropriate with key stakeholders, community and advocate on behalf of the Club
- Proactively build and strengthen positive working relationships with all associated external agencies including Netball Australia, DLGSC and key commercial partners

### **Hours of Work**

This is a permanent full time position. The sport industry operates outside of traditional business hours, including weekends. # **Location and Travel**

This position will be based at the Gold Netball Centre, 200 Selby Street, Jolimont, WA.

The nature of the position will require both intra and interstate travel from time to time, to attend meetings and events.

- Ability to foster and sustain positive relationships with a diverse group of stakeholders & memberbased organisations
- Tertiary qualification in management or related disciplines
- A current 'C' class WA driver's licence
- Preparedness to be flexible in respect to work hours

#### Safeguarding

NWA as a child safe organisation require all applicants that will work with children to undergo an extensive screening process prior to appointment.

Candidates must:

- Must be able to demonstrate an understanding of appropriate behaviours when engaging with children

# **Residency and Immigration**
