The Queensland Academy of Sport (QAS) has formally transitioned to a Statutory Body created under the Queensland Academy of Sport Act 2025 and is the state's leading high performance sport agency, currently supporting more than 500 elite athletes ranging from talented juniors through to Olympic, Paralympic and World Champions. QAS expert staff support athletes through in-house programs, partnerships with State and National Sporting Organisations, and individualised support for athletes on medal-winning trajectories to help them perform when it matters most.

Supporting strategic and operational decision-making across the QAS through robust financial modelling, analysis, insights and budget management; this role is key to ensuring financial stability and effective funding allocation to achieve both high performance and business outcomes.

As a member of the Senior Leadership Team this role works closely with the Minister, CEO and Board members, as well as building and leading a team of 30+ including six direct reports.

To be considered for this role you will have a proven track record in governance, risk and financial management, with a clear understanding of Board and government statutory body policy, reporting requirements, practices and protocols. The role will require a strong and dynamic communicator and people leader with exceptional well-developed interpersonal skills, including upward communication of issues to the CEO and Board. A thorough understanding of managing complex relationships is required to understand intuitively the leadership of diverse stakeholder groups.

The successful candidate will be an individual that possesses drive, passion, initiative and enjoys thinking on their feet to deliver optimum elite sporting outcomes within a financially constrained environment. With the proven ability to continuously improve and innovate operational processes, you will be well-placed to develop and drive best practice within the organisation, whilst respecting government policy. Your prowess in managing multiple priorities for a diverse range of stakeholders will be key to your success.

- Understanding of ethics and integrity for a public servant and an appreciation of appropriate Government and Ministerial Office practices and protocols.

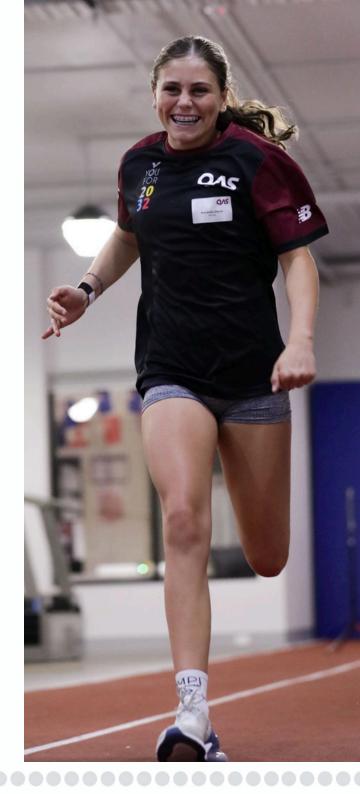
You will display outstanding judgement, high-level integrity, strong agility to adapt to a constantly changing environment, a strong achievement orientation, and excellent communication and negotiation skills.

You will be assessed on your eligibility and suitability for employment, as well as the diversity of lived experience you bring to the role, team and organisation. # **Residency and Immigration**

#### **Hours of Work**

This is a full time position. Given the unique nature of the sport industry, some out of normal hours work, including weekends, will be required to attend meetings, competitions and events.

This position will be based at the QAS office in the Queensland Sport and Athletics Centre in Nathan, Brisbane. The successful applicant may be required to work from any of QAS' locations.

The position may be required to travel to city, regional and interstate locations from time to time to attend meetings and events.
